Shaping the Future of Dental Care in Texas: TDA's Legislative Priorities for 2025

As the 89th Texas Legislative Session reaches its midpoint, the Texas Dental Association (TDA) is keeping a close eye on the slow progress in the House, where few bills have passed. While the Senate is moving forward smoothly, any new law must pass both chambers. Despite the gridlock, TDA's Legislative Team continues to push forward with advocacy for issues that matter most to Texas dentists. Currently, TDA is monitoring 468 bills that could affect the dental field, with 58 marked as key priorities. Here's where things stand on major issues:

- **Medicaid Dental Fee Increases**
After in-depth discussions with House budget leaders, the Health and Human Services Commission, and others involved in Medicaid dentistry, TDA is hopeful that a boost in dental reimbursement rates may be within reach.
- **Stopping Insurance Downcoding**
Senate Bill 1090, filed by Sen Bryan Hughes (R-Tyler) at TDA's request, aims to stop state-regulated dental plans from reducing reimbursement through bundling and downcoding. The bill is currently with the Senate Health and Human Services Committee.
- **Improving Access to Oral Health**
House Bill 1776, introduced by Rep Briscoe Cain (R-Deer Park), would require that the state's Oral Health Improvement Program be led by a licensed Texas dentist. The bill was recently heard in the House Public Health Committee.
- **Allowing Cosmetic Use of Neuromodulators by Dentists**
Senate Bill 1117, by Sen Charles Schwertner (R-Georgetown), would allow any Texas-licensed dentist to use botulinum toxin (or equivalents) for cosmetic purposes—provided they complete approved training. The bill is now in the Senate Business and Commerce Committee.

TDA is opposing House Bill 1803, which proposes joining a licensure compact for dentists and hygienists. On March 31, Dr Matt Roberts testified for TDA against the bill, citing concerns about patient safety and the unnecessary nature of the compact.

Dr Liang Hong Named Head of Public Health Sciences

Dr Liang Hong joined Texas A&M University College of Dentistry recently as the new department head of public health sciences. In December, he was named a Faculty Fellow of the Texas A&M Institute for Healthcare Access.

Before joining A&M Dentistry, Hong was professor and director in the Division of Community Dentistry at the University of Tennessee HSC College of Dentistry and professor in UTHSC College of Graduate Health Sciences and UTHSC College of Medicine, Department of Preventive Medicine. He maintained a general dentistry practice and treated a variety of patients, including oncology patients at the Special Care Clinic.

“This dental school, the location – the Dallas area and the state of Texas – provides huge opportunities to pursue my professional goal of improving the oral health and access to dental care of the public,” he said. “Oral health indicators in Texas are behind the national average and the objectives of Healthy People 2030. There’s a lot of work to be done here.”

Dr Lily Garcia, dean, said Hong has the professional demeanor and experience to advance the departmental staff and faculty through a deliberate focus on dental public health curriculum for the predoctoral and dental hygiene students.

“He has quickly learned the vital role that the faculty contribute to A&M Dentistry clinical outreach,” she said.



Dr John K. Neubert Takes the Leadership Reins of Biomedical Sciences

Texas A&M College of Dentistry welcomed Dr John K. Neubert on February 1 as the new department head of biomedical sciences.

Dr Neubert joined the dental college after more than 20 years on the University of Florida faculty, including several years as the director of predoctoral orthodontic education. A translational researcher, his work is recognized worldwide.

“I am so pleased Dr. Neubert joined our faculty,” said Dr Lily T. García, dean. “He comes with the expertise, academic experience and a successful track record in protocol-driven research. He is focused on engaging our faculty members in the Department of Biomedical Sciences as we work together to advance the mission of the A&M College of Dentistry.”

Neubert said moving into an administrative role is a natural step after many years as a researcher, clinician and teacher. His background is in neuroscience, pain research and therapeutics, and he pursued a leadership role at the dental college because he wanted to focus more on leading a basic science and research program.

“Even though I’m a dentist and an orthodontist, I consider myself a researcher and academic,” Neubert said. “I saw the position posted for biomedical sciences and that seemed like a more natural fit for me as far as what I want to do.”



Dr Jacqueline Plemons Tapped for Inaugural Role as Executive Director of External Affairs

Dr Jacqueline Plemons was named as the inaugural executive director of external affairs at the College of Dentistry.

Dr Plemons is an alumna of Baylor College of Dentistry (BCOD ’86) earning her DDS, Certificate in Periodontics, and MS in Oral Biology/Dentistry. She is a clinical professor, diplomate of the American Board of Periodontology, and director of the Stomatology Clinic services division.

Joining A&M College of Dentistry full-time, she will be responsible for identification and development of collaborative education opportunities in alignment with the mission of the school, provide oversight and approval, and coordinate with the Office of General Council when reviewing affiliation agreements in support of our programs, among other roles. In addition to this full-time faculty position, Dr Plemons will continue her work in teaching and managing the stomatology services. ■

Texas Mission of Mercy (TMOM) Brazos Valley 2025: A Life-Changing Weekend of Free Dental Care

Texas Mission of Mercy, Inc. held a 40-chair TMOM event on February 21-22 in the Brazos Valley. TMOM Brazos treated 705 patients and provided \$723, 159 worth of care.

Co-chaired by Drs Jennifer Hathaway and Delton Yarbrough, it was a powerful demonstration of community, compassion, and care, bringing together hundreds of volunteers and dental professionals, including dentists, hygienists, dental assistants, and general support staff, to provide life-changing oral health services to those in need.

The mobile dental clinic was set up at Christ Church, offering free extractions, fillings, cleanings, and other critical dental treatments to hundreds of underserved Texans who might not otherwise have access to care.

Pre-screening events were hosted at The Bridge Ministries and Health For All Clinic, ensuring that patients most in need of care were prioritized and prepared ahead of the event. This proactive approach streamlined the treatment process and allowed TMOM to maximize its impact over the 2-day clinic.

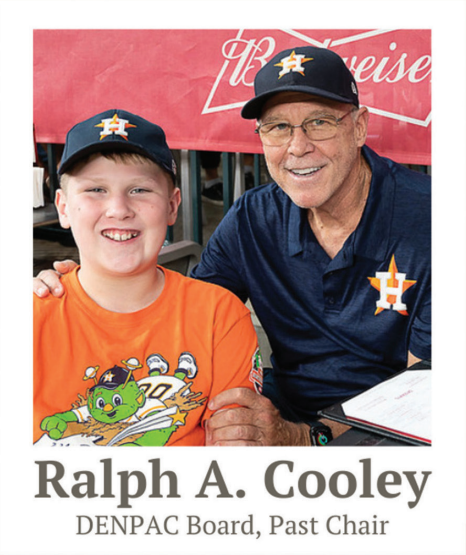

According to Texas state law, political action committees may only accept contributions from individuals, professional corporations, and professional associations. State law requires political action committees to request and make best efforts to report the name, mailing address, occupation, and employer for each individual whose contributions aggregate in excess of \$100 in a calendar year.



TSBDE Rule Update

This recurring section is designed to help TDA members keep up with important Texas State Board of Dental Examiners (TSBDE) rules, other regulations, and state law affecting their practices.

The following Texas State Board of Dental Examiners (TSBDE) rule adoptions were published on March 7, 2025, in the *Texas Register* with an effective date of March 13, 2025.

22 Texas Administrative Code §113.2, X-Ray Laboratories
The amended rule removes the requirement that dental patients must be protected by a lead apron with thyroid collar. The American Academy of Oral and Maxillofacial Radiology (AAOMR) issued guidelines titled “Patient Shielding During Dentomaxillofacial Radiography” where the AAOMR recommended discontinuing the use of lead aprons and thyroid shields when making X-rays. The Board held a stakeholder meeting on September 27, 2024, where most stakeholders stated that Board rules should be amended to remove requiring the use of lead aprons and thyroid shields based on the AAOMR guidelines.

22 Texas Administrative Code §108.42, Obtaining a Permit
The amended rule removes the requirement that a mobile dental facility or portable dental unit must have a lead apron with thyroid shield when x-rays are made. The AAOMR issued guidelines titled “Patient Shielding During Dentomaxillofacial Radiography” where the AAOMR

recommended discontinuing the use of lead aprons and thyroid shields when making X-rays. The Board held a stakeholder meeting on September 27, 2024, where most stakeholders stated that Board rules should be amended to remove requiring the use of lead aprons and thyroid shields based on the AAOMR guidelines.

22 Texas Administrative Code §111.1, Additional Continuing Education Required
The amended rule removes subsection (a) and paragraph (b)(1) because they are no longer in effect. The current continuing education requirement regarding controlled substances is found in paragraph (1) of this amended rule and in 22 Texas Administrative Code §104.1(2)(B). The proposed amendment also updates the title for 22 Texas Administrative Code §104.1.

22 Texas Administrative Code §114.12, Continuing Education for Certificate Holders
The amendment updates the rule to reflect that dental assistant registrations have a biennial renewal cycle.
